

Brief History

Begun in Summer 2003, this database was designed to record details about printed and online primary sources that can shed light on the history, literature, culture, and religion of the Middle Ages.

Scope and Coverage

This database provides a searchable bibliography of texts - from private letters, wills, and household accounts to literary works, philosophical treatises, chronicles, court proceedings, church records, and a host of other documents - that were written in the Middle Ages and are now available in printed or online editions and translations. In Phase-I, it was focusing on primary sources that have been translated into English and are accessible in

most college libraries or online. The database is currently weighted towards primary sources relating to England, France, and Ireland. But it now adding more materials for other European countries. In this tool the primary sources included, primarily from the period between roughly 300 and 1500, although there are sources that date from before and after these years.

Kind of Information

In Online Medieval Sources Bibliography, each entry provides bibliographic information like Medieval author(s) name, Modern author(s), period of publication, original language, geographical region(s), translation language, record type, subjects, apparatus, comments, introduction summary, cataloger, ISBN etc.

Comments:

The *Gesta Danorum* is a chronicle of the Danish kings, starting with the legendary and mythical past and ending in Saxo's own day. This source offers one of the most extensive looks at the history, folklore, and legends of Northern Europe, including tales of Scandinavian gods. The first nine books are mostly legendary; book nine ends with Gorm the Old, the first documented king of Denmark in the early 10th century. The remaining seven books (which were probably written first) are historical, and are one of the only sources for early Danish history. Each of the books is preceded with an introductory statement giving historical background. After the translation a commentary by the editors follows, giving a more detailed look into the history, linguistics, and literary merits of the chronicle.
