

The journal was established by Dianne Longley and Vivienne Harpwood and was edited by Shaun Pattinson from 2005 to 2011.

## ***Scope and Coverage***

Medical Law International is a peer-reviewed law review that Covers matters of interest to academic lawyers, practicing lawyers, medical ethicists, bioethicists, healthcare professionals, healthcare and healthcare service administrators, and those studying aspects of medical law and ethics.

Medical Law International publishes Papers up to 10,000 words, shorter Case/Legislative Critiques up to 4,000 words, and Book Reviews up to 2,000 words.


## ***Kind of Information***

Medical Law International is an international peer reviewed journal that seeks to address new and emerging issues in medical law, medical and bioethics, and health governance around the world. The journal has a strong emphasis on international and comparative trends in law and medicine, and the Editors welcome new papers that fall within the aims and scope of the journal. This journal is a member of the Committee on Publication Ethics (COPE).

Medical Law International operates a strictly anonymous peer review process in which the reviewer's name is withheld from the author and, the author's name from the reviewer. Medical Law International offers optional open access publishing via the SAGE Choice programme. This journal is able to host additional materials online (e.g. datasets, podcasts, videos, images etc) alongside the full-text of the article. These will be subjected to peer-review alongside the article. Medical Law International and SAGE take issues of copyright infringement, plagiarism or other breaches of best practice in publication very seriously. Medical Law International seeks to protect the rights of authors and always investigate claims of plagiarism or misuse of published article. Articles are presented in pdf or full text format.

There are no fees payable to submit or publish in this journal.




